### 13. Mention Five Academic Mile Stones of the HAEI in Last Five Years

IIAT is one of the Imayam Group of Institutions that are located on Thuraiyur – Namakkal highway six KM away from Thuraiyur in Kannanur village. It was sanctioned by Tamil Nadu Government in G. O. Ms. No. 140 of Agriculture (AU) Department dated July 2, 2013 (*Annexure I*). It is Affiliated to Tamil Nadu Agricultural University, Coimbatore (*Annexure II*). IIAT is functioning since July 27, 2013. This institution imparts value based education to empower students and equip them with required knowledge to modernize agriculture and thereby sustain the livelihood of farming community. At most care is taken to ensure the employability of graduates in the present day competitive job market.

**IIAT's Vision** is to educate students and transforming them into knowledge empowered graduates with standards that are required to sustain the livelihood of farming community.

**IIAT's Mission:** IIAT will impart futuristic technical education in agriculture domain and in still high level of etiquette through our dedicated staff members thereby students could pioneer technologically and contribute for the betterment of our rural society.

IIAT started function with initial admission strength of 60. The student intake strength gradually increased over years as given below:

The present admission strength is 120 and this increase was accomplished through rigorous review of the infrastructural developments and faculty strength and its quality by repeated visits and scrutiny by the Standing Committee from TNAU, Coimbatore.

#### 13.1 Milestone

##### I: Educational Excellence

Our endeavour is towards continuous all round development of students through rigorous curricular and co-curricular activities. Even though located in a rural setting, IIAT provides opportunity for its students to excel in their profession and life by imparting high quality education through its strong and dedicated faculty. The students are admitted every year in the college based on the eligibility criteria prescribed by Tamil Nadu Agricultural University, Coimbatore. The students who are poorly performing in the classes are identified and given special coaching to catch up with rest of the students. During the last 3 years, 184

students have successfully completed the B.Sc. (Ag.) degree from IIAT and they are excelling in the different fields of agriculture and related areas after their placement. Since its inception, IIAT is taking several efforts to maintaining high student - teacher ratio (at present 10:1), and to employ highly qualified and experienced teachers. To enhance the quality of education individual attention is ensured to each student and there by passing percentage is maintained above 90 per cent. Around 70 per cent of the students are securing OGPA of more than 8 out of 10. Further, our students are also excelling in the ICAR-JRF examinations. For example one student obtained 14<sup>th</sup> rank in Plant Science during 2017-18 and one student got selected in MBA during 2019 -2020. Around 15 graduates (2017-2018) and 04 graduates (2019-2020) are pursuing M.Sc., (Ag.) at Tamil Nadu Agricultural University, Coimbatore and two students are in higher studies in **UK** and **Australia**. One student was pursuing MBA at IIT Trichy. As an incentive to meritorious students in different disciplines IIAT has instituted five Gold Medals. These Medals are given to the best outgoing student on the basis of higher OGPA and topper from three departments, viz., Crop Improvement, Crop Management and Crop Protection. The college has an attrition percentage of 8.88 during the past five years.

## **II: Employability of graduates**

IIAT is committed to enhance the employability (formal and self) of the graduates by creating placement center and by triggering the fullest potential of the students through appropriate placement guidance. Due to high quality education offered in IIAT and soft skills imparted to them, graduates of IIAT were most preferred in the job market; the graduates were employed in government and in private sectors (mostly in agribusiness houses).

- Three graduates joined State Department of Agriculture and three in Department of Forestry in Government of Tamil Nadu.
- 13 graduates were given appointment by the private agencies such as M/S Rasi Seeds, IFFCO, Excell Crop Care Ltd., Green Tech Bio Pvt. Ltd., National Agro Foundation, and Micro Finance Pvt. Ltd., Erode.
- Four Students cleared IBPS – SO examination and placed at various banking sector.
- Five students selected School Teaching position at Government School (Vocational Teaching for Agriculture)

## **III: Outreach Activities**

IIAT, besides teaching, undertakes extension activities through it are on and off campus outreach programmes in order to help the farming community in and around the Trichy and Perambalur Districts. The faculty members and students in collaboration with various institutions organized 'Farmers' Mela'. Scientists and farmers interface was enabled on this occasion and farmers' queries were answered by the faculty of IIAT. The Rural Work Experiential is leveraged to disseminate agricultural technologies to the farmers besides practical learning by the students. The "*PongalVizha*" (Harvest Festival) is celebrated every year to enlighten the students about the importance of agricultural heritage in Tamil Nadu. Farmers are also involved and they are honoured in this function. IIAT supplies planting material and vermicompost through its demonstration units to the farmers.

- The outreach efforts involving faculty and students at IIAT reached the farmers in 10 development blocks in Trichy and Perambalur districts. Besides, need based trainings were imparted to the farmers and farm women by the students in collaboration with IIAT faculty and Extension Personnel from the Department of Agriculture.
- IIAT faculty has so far given more than 45 invited talks to farmers through KVK and ATMA scheme.
- IIAT faculty has so far delivered more than 60 lectures to students of private Arts and Science Colleges in around Trichy District to create awareness on the recent developments in agricultural Sciences.

#### **IV: Capacity Development for Staff and Students**

Opportunities were provided to the faculty of this college in updating their knowledge and skill through attending seminars/workshops/symposium/trainings conducted in reputed institutions and organizations. Teachers are trained in educational technology and writing winning project proposals for research grants by outsourced experts. Guest lecturers were arranged periodically for the students by inviting resource persons with varied expertise from both within and outside Tamil Nadu. Further the students are exposed to various sports and games through IIAT's well organized/equipped Physical Education wing of the faculty.

- So far more than 90 guest lectures on various topics have been organized in IIAT to enhance the knowledge base of the students and staff.
- IIAT has developed strong linkages with different organizations and agro-industries in order to improve students' learning ability and their capacity to understand field level problems and solving them. The institutional and industrial tie-up covers T.I.M.E Institute, Agribusiness Houses involved in cashew, coffee and aqua food processing, poultry farms, banana producer organization, agro service centre, general food processing, export house, cooperative sugar mill, etc.
- IIAT faculty has so far participated in more than 105 National and International conferences across the country.
- Apart from academic activities, the students participated in many State and National level sports and games. So far they won **2 medals in National level** and **54 medals in State level**.

#### **V: Infrastructure Facilities**

To keep the learning ambience conducive for the modern generation students, state of art facilities have been provided in IIAT Campus. As per the standards set by Tamil Nadu Agricultural University, this college has scored 70 per cent degree of compliance to its prescribed standards as per the recent (2019) Standing Committee Report of Tamil Nadu Agricultural University, Coimbatore. Hence, Tamil Nadu Agricultural University to which this college is affiliated has increased allotment of students from 60 to 120 owing to creation of the aforesaid infrastructures, provision of learning resources, standard and quality of instruction, and development of general amenities in the college as furnished below:



- Six numbers of smart classrooms equipped with interactive boards and LCD projectors have been provided in the college. These class rooms with an area of 7564 sq.ft. are green in the sense they have good light and ventilation. Each classroom is designed to accommodate 120 students.
- For conducting practical classes separate laboratories, one each for every department, with advanced facilities, viz., modern equipments, work tables with electrification points, common gas connections, and charts and display boards have been provided in the college. They are 14 in numbers and their total area is 17119 sq. ft. All these laboratories are furnished with sufficient number work tables fixed with rigid granite top to accommodate 30 students per batch. Besides, all the laboratories are equipped with necessary latest version of instruments to get precise data by the students in their practicals.
- In addition, several physical facilities such as poly house, glass house, mist chamber, vermicomposting unit and Integrated Farming System (IFS) unit have been established in the college campus.
- A central library is available with an area of 1750sq.ft. The library is furnished with 5050 books pertaining to Agriculture and related fields. Besides, 5 magazines, 3 scientific journals and 8 newspapers, 1200 e-books have been purchased / subscribed for the benefit of the students and faculty. Fortnightly Employment News in both Tamil & English are also purchased and kept in the library as a source document for career development of the students.
- The college and hostel premises are provided with internet facility with 12 Mbps speed for surfing in search of information on agricultural subjects by the students and faculty.

- The college implements the curriculum as prescribed by Tamil Nadu Agricultural University, Coimbatore.
- National Service Scheme programme is organized by the students in the surrounding villages of the institute.

#### **d). Green Initiative Projects**

As Green Initiative the following projects and practices are followed in IIAT:

- Rain Water Harvesting is practiced in IIAT Campus since 2013.
- An Eco-club was started during the year 2014 with student volunteers to create awareness about Green Initiatives.
- IIAT has constructed well designed sewage treatment plant in an area of 2555 sq.ft. to handle solid and liquid wastes generated from college as well as from student hostels.
- Solid wastes from cafeteria are processed as manure/vermicompost.

#### **15. Does the Institution has a mechanism for counseling and guidance for the College and degree programme**

Yes. As per ICAR norms Ward Counselors are nominated from among the academic staff of the college by the Principal. Six to Ten students are allotted to each Ward Counselor during the commencement of first semester at the time of registration. The same teacher continues to be their Ward Counselor till the wards in link with her/him completes their degree programme. The ward counselors act as a local guardian and conduct ward council meetings at weekly intervals to monitor their overall academic activities and extra - curricular activities for the entire period of course programme and solve any difficulties and problems faced by their wards.

### **Role of ward counselor**

- To determine the choice of courses and the course load which the student may take in a semester.
- To establish and foster close relationship with the students.
- To conduct periodical meetings of the wards once in a week.
- To review their academic performance and personality development and intervene wherever necessary as corrective measures.
- To look after overall development of a student and to advise them in respect of co-curricular activities and his/her personal difficulties.

- Yes. Hi Speed (12Mbps) internet facility is provided in IIAT Campus both in College and Hostels. This facility is available for surfing both by staff and students. The 40 systems in the Computer Lab are enabled for surfing the internet. Besides, all faculty rooms are equipped with computers and internet facility.

### **Research:**

- Dr.S.Elayabalan, Assistant Professor (Biotechnology) currently working as a collaborative Researcher (Biotechnology) with International Center for Tropical Agriculture (CIAT), Columbia for the project on "Artificial intelligence Powered Banana Diseases and Pest Detection: Part by Part Model".

### **Extension:**

- As an extension programme, through RAWE the latest agricultural technologies are demonstrated in the fields of farming community in Trichy District.
- IIAT staff members given more than 45 invited talks to farmers through KVK and ATMA scheme.

- Yes

Students' feedback on teachers' performance at the end of each academic session is evaluated based on the criteria such as:

- Clarity in subject delivery,
- Subject matter related to the course,
- Use of audio visual aids and other properties in the class,
- Providing suitable literature in time to the students,
- Interaction with students during the class,
- Impartial behavior towards students and student friendly approach in the class.

The rating by the students is analyzed and training for improving teaching skills of the staff is imparted periodically. This helps to maintain standards and equity.

**19. Did the academic audit of the Institution was conducted in last two years?**

- Yes. It is achieved through the rigorous review by the Standing Committee of Tamil Nadu Agricultural University. During the current year the Standing Committee visited two times for this auditing on 13.05.2019.
- The IIAT scored 70 per cent degree of compliance in the prescribed standards. Based on this compliance in academic auditing by the Standing Committee, the TNAU increased the student strength from 115 to 120 for the Academic year 2019-20.
